STATUS UPDATES

- a. **Caltech Chemical Hygiene Plan ([CHP](#))**
 - i. In compliance with the California Code of Regulations (T8 CCR, 5191) the Caltech CHP conveys procedures required to protect Campus personnel from exposure to hazardous chemicals.
 - ii. Under the leadership of Caltech's Institute Chemical Hygiene Officer, Nate Siladke PhD, all controls implemented as part of the CHP at the EH&S, Division, and Laboratory levels were found suitable and efficiently operating. (No findings.)
- b. **EH&S Website Spotlight: Hearing Conservation Program**
 - i. Campus-wide noise surveys of all areas that fell within the program were performed in October and November 2023.
 - ii. Recorded findings revealed none of these work areas fell within OSHA thresholds for noise exposure. The Program was removed from the EH&S website in December.
 - iii. NOTE: The Supervisor/Department must notify the Environmental Health and Safety Office ([EH&S](#)) of any noise concerns, complaints, or potential campus noise hazards.
