**CampusOptics is the EH&S work management tool that was fully launched in 2025. Using this tool over the course of the year:**

- EH&S completed 192 laboratory inspections including 95 labs inspected for the use of biological material.
- Completed fire/life/safety inspections for the twelve student houses on campus, the Children's Center, thirteen machine shops, and all campus dining areas.
- EH&S engineers were deployed on campus individually and in teams for over 200 instances to follow-up on incidents, assess hazardous conditions or address campus safety needs.
- 41% of EH&S interventions were related to injuries, with over half of these events involving lifting, repetitive motion, or slips, trips, and falls, underscoring the importance of everyday safe work practices.

**In 2026, EH&S is expanding the use of CampusOptics, at no cost to campus users:**

- Providing direct campus-wide access to online links for reporting incidents, near misses, and hazardous conditions.
- Making it easier for all community members to raise concerns and actively support a safer campus environment.
